Regarding Local government reorganisation Councillor Edge recommended that we reply both as individuals and as the PC in order to give our opinion on the way that the councils are formed.

Highways: the four sleeping policemen at the East end of the village are supposed to be being addressed. There is no exact timescale for this but should be sometime this summer.

The parish council concerns regarding the dangerous junction near the Red Lion was discussed with Cllr Edge.

Road on the far side of Dullingham will be resurfaced in the autumn.

The state of Common Road was raised by the Parish Council with Cllr Edge.

Coles Lane is not currently treated as an adopted road, but it is believed to be adopted.

Councillor Monks raised the issue of the Fenland Reservoir/strategic water transfer - space has been reserved on the development land for the pipe and there was interest from residents about this.

Public Rights of Way Hierarchy engagement

The path to Burrough Green is a priority for the village as it allows access between the villages. The other lesser priority is the rest of the Icknield Way. It was agreed that Cllr McIntyre will respond to the consultation on behalf of the PC before the deadline of 31st July.

DISTRICT COUNCILLORS' REPORTS Bottisham Ward Seminar on Local Government Reorganisation (LGR) Councillors were presented with the work so far done on LGR; three options had been selected as being the most sensible from the six that were first proposed. The three options are: 1. Peterborough City, Huntingdon and Fenland DCs form one unitary, and Cambridge City with South Cambs and East Cambs DCs form another unitary; East-West 2. Peterborough City, Huntingdon, East Cambs and Fenland DCs form one unitary, and Cambridge City with South Cambs DC form another unitary; horseshoe 3. Peterborough City, East Cambs and Fenland DCs form one unitary, and Cambridge City with South Cambs and Huntingdon DCs form another unitary; North-South Options 1 and 3 would be about equal in terms of population, whereas Option 2 would be unbalanced in terms of population, but might be acceptable soon since the area surrounding Cambridge is deemed to increase rapidly in size. Parishes will be consulted as to their preference, once more detail is provided. Ward surgery A surgery at the Pavilion on the Denny at Swaffham Bulbeck on Thursday 24 July from half past six for an hour, followed by socialising at the Black Horse in the same village.

LOCAL GOVERNMENT REORGANISATION

Proposals for new 'unitary' councils to replace our county and district councils continue to be developed and have been narrowed down to three options. All three divide Cambridgeshire & Peterborough into just two councils, as follows.

Option A

- East Cambridgeshire, Cambridge and South Cambridgeshire

- Huntingdonshire, Fenland and Peterborough

Option B

- Cambridge and South Cambridgeshire
- East Cambridgeshire, Huntingdonshire, Fenland and Peterborough

Option C

- Huntingdonshire, Cambridge and South Cambridgeshire
- East Cambridgeshire, Fenland and Peterborough

The County Council will be supporting further work on Option A, while the leadership of East Cambridgeshire District Council is supporting Option B.

Option A is the only option which retains East Cambridgeshire's links with Cambridge, where a huge proportion of East Cambs residents work, study, obtain health care, and travel for leisure and entertainment. Options B and C would remove any democratic input by East Cambridgeshire residents into decisions which have major impacts on their lives.

The existing Cambridgeshire & Peterborough councils must write to the Government by the end of November, with proposals for no more than three different options. Each council leader can support only one option.

Final power rests with the Government, who may choose or amend any of the above proposals or even substitute them with a proposal of their own. The Government must consult on whatever it proposes.

An East Cambs parish forum will also take place on Wednesday 9 July at 2:00PM.

Meanwhile, there is a survey—not a consultation—which closes on 20 July. I would strongly encourage the council to respond with strong responses for our connection to Cambridge but would also encourage individuals responding as they see fit.

STRATEGY RESOURCES & PERFORMANCE

End of year sees smaller overspend than predicted

The council ended 2024/25 with a revenue overspend of £4.45M. While no overspend would be preferred, it is less than predicted, and Cambridgeshire County Council remains in a healthier financial position than many other authorities. Cuts from national government are biting everywhere. Capital expenditure for the year was closer to plan than anticipated, a much-improved position on previous years.

ADULTS & HEALTH

New public health strategy

A variety of contracts have been retendered for home adaptations, adult social care transport, drug and alcohol services, and adult weight management services. The committee also reviewed and endorsed a new Public Health Plan to 2030. Priorities identified in the strategy are obesity, particularly in children in deprived areas; mental health and wellbeing; smoking and preventable mortality; and health and work support initiatives.

Health scrutiny

The council's Constitution & Ethics Committee has agreed to recommend that the Council set up a separate Health Scrutiny committee. The intention is to increase the focus of the council's scrutiny of our health partners.

ASSETS & PROCUREMENT

Breaches of procurement rules

The council's Assets & Procurement Committee considered its first report on breaches of procurement policy or legislation, several of which date back more than five years. There were more breaches than originally expected, however none involved fraud, corruption or financial irregularities.

Under the Liberal Democrats, action is being taken to change organisational culture and ensure transparency in procurement. Corporate performance in this field is generally improving.

CHILDREN & YOUNG PEOPLE

New ways of building schools

The council has agreed to enable academy schools to lead on construction of some expansion projects on their premises, and developers to lead on some new build schools. The council has also agreed a new service in Harston with residential placements for two children with complex needs.

COMMUNITIES, SOCIAL MOBILITY and INCLUSION (COSMIC)

Adult learning services earn high praise from Ofsted

Learners and apprentices through the council's adult learning services thrive due to the warm, nurturing and inclusive learning environment and substantial new knowledge and skills they learn, says a recent Ofsted report.

Cambridgeshire Skills offers education and training for adult learners in the county, the largest programmes of which are tailored learning, adult skills and family learning. Courses are run by sub-contractors and are offered online and in around 87 community venues across Cambridgeshire, including community centres, libraries and schools. The service works closely with the county council's Learning and Development team to provide apprenticeship opportunities.

The Ofsted inspection of the two teams, which took place in late April and early May,

found the overall effectiveness of the service to be Good. It judged the behaviour and attitude of learners to be Outstanding, with a rating of Good awarded in every other category.

Household Support Fund (HSF) reopens

Applications to the HSF reopened in April. The Fund is provided by Government to support households experiencing immediate financial hardship and the rising cost of living.

The Fund will run from Tuesday 1 April 2025 to Tuesday 31 March 2026. Eligible households can apply for one £110 voucher in this period. More information, including eligibility criteria and application form, can be found on our website.

Government steps in to take control of Fens reservoir plans

The Government has announced it is stepping in to take over delivery of nine reservoirs, including the Fens reservoir planned near Chatteris. The announcement indicates that this will 'accelerate' completion of the reservoir, though it gives no date, and it is not clear how much faster the Government could start water flowing than the currently advertised date of 2036.

Planning for a low carbon, resilient energy future

An informal engagement survey is seeking the views of Cambridgeshire residents on the future of renewable energy, net zero, and energy in our county.

Council recognised for climate leadership

Cambridgeshire County Council has been ranked as one of the top-performing councils in the country for the action it has taken towards Net Zero.

The Council achieved a score of 55 per cent in the Climate Action Scorecards published by Climate Emergency UK, placing it second among all comparable local authorities in England. The score marks an improvement of 11 per cent from 2023, making Cambridgeshire County Council 'one of the most improved county councils', according to Climate Emergency UK.

The Scorecard assesses more than 400 councils and combined authorities against a broad range of climate criteria, including transport, buildings and heating, biodiversity, planning, governance, waste, and community engagement.

HIGHWAYS & TRANSPORT

Local Highways Improvement Panel meets to score bids

The East Cambridgeshire Local Highways Improvement (LHI) Panel, consisting of five councillors, met last month to score three 'complex' funding bids, from Sutton, Haddenham, and Littleport. Recommendations for these schemes, along with nine 'non-complex' schemes scored by council officers, will be presented to the Highways & Transport Committee in October for consideration. Three of these cover LHIs in the Woodditton division.

Public rights of way

Parish councils have been invited to help develop a public rights of way (PROW) hierarchy. The hierarchy will rank local rights of way by their importance to our communities. This includes gaining an understanding of routes that are important for utility journeys (such as accessing workplaces, schools or services) and for leisure and recreation.

A questionnaire has been sent to all parish councils for feedback on the rights of way used in our local areas. Parish councils are invited to contact local walking or cycling groups, or other local rights of way users, for their input. The questionnaire will close on Thursday 31 July.

Guided Busway safety

By historical accident, the Cambridgeshire Guided Busway is regulated by the Health & Safety Executive, rather than as a typical highway or a typical railway. Following the recent prosecution relating to three tragic deaths between 2015 and 2021, the council has agreed to fence its entire length and remediate flooding at three key points.

A14 retrospective

There is unanimous agreement across the council about the unsatisfactory performance of National Highways in its improvement programme on the A14. The project left a very large number of unresolved issues in its wake, and the council is continuing to engage with National Highways to seek resolutions to these.

Highways satisfaction survey

At least 3,300 Cambridgeshire residents are being asked for their views on the County Council's highways and transport services in the National Highways and Transport Public Satisfaction survey. In this annual survey they will have the opportunity to comment on everything from the condition of roads and footpaths to public transport and the quality of cycling facilities.

A questionnaire is being sent to a random sample of residents, followed by a reminder. Those who
